

Up on the Rooftop Christmas Giveaway Bedre Fine Chocolate

Official Rules

1. Bedre Fine Chocolate is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Bedre Fine Chocolate is giving away a Christmas Sleigh in the "Up on the Rooftop" promotion.
2. The contest is open to anyone 18 years of age or older. The following individuals or entities are not eligible to participate or win during this promotional activity: Employees of Bedre Fine Chocolate and their immediate families (spouses, parents, siblings, and children); Employees of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations, or laws.
3. Beginning Sunday, October 22 through Monday, December 11, 2017 Patrons will be able to earn entries for the drawings in the following ways:
 - a. Earn 1 entry for every \$25 Spent in the retail store or online .
 - b. Earn 1 additional entry if valid email is provided (valid one time per patron).
 - c. Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.
4. On Monday, December 11, 2017 a winner will be randomly selected and announced on the day of the drawing from among all eligible entries received during the contest period. The drawing will occur from the hopper of the entries and one (1) winner will receive a Christmas Sleigh (Valued at \$649)
 - a. Entries must have complete information and be legible,
 - b. Bedre Fine Chocolate's manual drawing system will be the sole determinant of Grand Prize winner.
