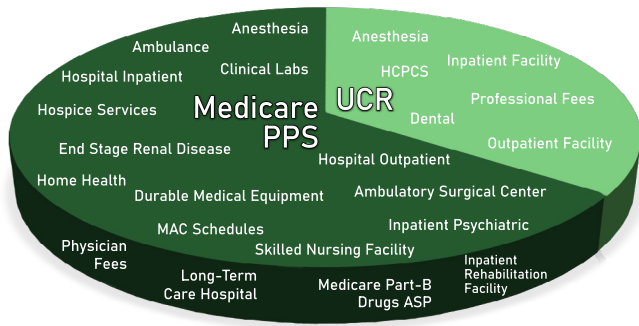
MEDICARE PRICING ACCURACY

Second, just because the MACs are supposed to price some services doesn’t mean that they do. That’s why C4RBP also contains the optionally available Context Usual, Customary, & Reasonable (UCR) data.
