



Case Study: Coweta County School System

Background

In a given year, about 22,500 students attend the Coweta County School System (CCSS) in Newnan, Georgia. Comptroller Chris Latimer, a CPA, had been with CCSS for 11 years as Assistant Comptroller before his recent promotion.

The Challenge

According to Chris, his primary concern was ensuring the accuracy of CCSS' reporting. As he puts it, "We were using an older system. As we were evolving to new reporting standards in the state, we needed a new financial package that could meet our needs and help us meet deadlines. We are very cognizant that we have a duty to the taxpayer and to our system to make sure that our financial reporting is very sound and solid and to make sure that we report to all of our stakeholders in the way they need it to be reported."

However, as we learned, his worries ran deeper than any single financial function. Chris says of his previous software solution, "The thing that was keeping us up at night is actually the support that we were receiving at that time in our old system. It was a smaller company that we were using, so we were really concerned about continuity if something were to happen to that support system."

The Solution

"To come up with a permanent solution," Chris explains, "we decided that we would demo different products. An easier solution to the reporting requirements is what we wanted. We wanted a product that could be

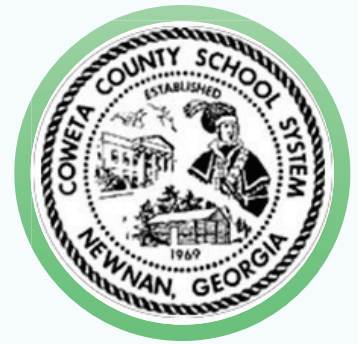
easy to use, a product that had a support system, that we could get solutions to problems quick. We didn't want to have to put in a service ticket for our problem and have maybe a 24-hour or a 48-hour wait. We wanted a team that could support us at all times."
